PURPOSE

The New Jersey Department of Education's NJ SMART system (NJ Standards Measurement and Resource for Teaching) is a comprehensive statewide longitudinal data system solution that serves multiple purposes: staff/student identification, data warehousing, data reporting, and analytics. The purpose of this Guide is to help school district leaders, Local Education Agencies (LEAs), grant administrators, educators, and other stakeholders understand how NJ SMART data reports and resources can be used to assist with district and school improvement planning.¹

For example, for Cohort 2018, the August 31, 2018 Snapshot would reflect their official 4-year graduation rates, the August 31, 2019 Snapshot would reflect their official 5-year graduation rates, and lastly, the August 31, 2020 Snapshot would reflect their official 6-year graduation rates.

*** **State Snapshot Report:** The "Fall" Snapshot is taken on or around 10/15/xx and imported into reports generally by early November of each year. The "End of Year" (EOY) Snapshot is taken on or around 8/3/xx and imported into reports generally by early September of each year (**NOTE:** Outside of NJ SMART snapshots and submissions, other updated data such as assessment results and graduation appeals are loaded into the system as it becomes available).

Local Data Mart Report: If a district updates an area of their data, that data will get pulled in with the nightly refresh of the Local Data Mart. As such, if they run a report the next day using the Local Data Mart option, the results will show updated data as compared to the results from the day prior. The various reports all pull from different areas (SID, SpEd, etc.), so only areas updated by the district will be updated in the report.
