## NJ SMART Special Education Scenarios

While the Special Education Student Data Handbook outlines the data elements and validation rules, this document outlines some of the common scenarios in the Special Education Submission and provides explicit clarification to some of the common misconceptions related to the Special Education Submission.

### **Students that should be included in the Special Education Submission:**

1. All students with an IEP that is in effect as of 10/14/22 for which the district had CST responsibility.
2. All special education students who were reported in the 10/15/21 Special Education submission file, but who have been declassified or determined ineligible after 6/30/22 and on or before 10/14/22.
3. All new referrals on or after 7/1/21 that are still in process (**exclude** students where the new referral was withdrawn, or the Child Study Team (CST) found that evaluations were not warranted, or the consent to evaluate was either refused or revoked).

### **Students that should be excluded in the Special Education Submission:**

1. Special Education students who have been parentally placed in a non-public school.
2. Students for which the district does not have CST responsibility.
3. Any referral on or after 7/1/21 that has left the district prior to 10/14/22.
  - a. Students in the referral process who leave the district prior to eligibility determination
  - b. Students found eligible who leave the district prior to 10/14/22
  - c. Students found ineligible who leave the district prior to 10/14/22
  - d. Special education students with an IEP in place that spans the 10/14/22 date, but who exit special education prior to 10/14/22
4. Student attends a vocational school full time.
5. Special Education Students not receiving services because they are Home School students for whom the district does not provide services.
6. Special Education Students transferred out of the district on or before 10/14/22.
7. Special Education Students transferred into the district AFTER 10/14/22.

## New Referrals (Students referred on or after 7/1/21)

Data to be reported (in addition to the student demographic information of LID, SID, First Name, Last Name, and Date of Birth)

**Scenario:** New Referral, Student is eligible, IEP implemented, No Annual Review

**Description:** Student was referred on or after 7/1/21 and is currently receiving services as of the 10/14/22 submission date. Student has not yet had an annual review meeting.

**Description:** Student is referred on or after 7/1/21, evaluations are warranted. Parents give consent to evaluate, and then revoke consent.

**Note:** If the parents revoked consent to evaluate (therefore the student was not evaluated), student should not be reported since the district is not proceeding.

**Scenario:** Student is eligible, one (1) or more Annual review meetings held by 10/14/22, Parent refuses consent for Reevaluation on or before 10/14/22 but after 6/30/21.

**Description:** Student was referred one or more years ago and consent is refused at the re-evaluation meeting on or before 10/14/22 submission date.

**Note:** Student should be submitted to the Special Education Submission with a “99” Declassified Classification. If the consent was refused before 6/30/22, the student should be declassified in the EOY SID Snapshot with a “99” code.

## Exited Students

Students who were new referrals (referred on or after 7/1/21) or found eligible on or after 7/1/21, but exited **special education** on or before 10/14/22 because of one of the following reasons:

- Dropped out
- Deceased
- Reached maximum age
- Moved and are known to continue
- Move and known not to continue
- Graduated

**NOTE:** The above students are not reported to the Special Education Submission and must be inactivated in SID Management.

## Transfer Students

### Students Transferred Out

**Scenario:** A student referred on or after 7/1/21 and found eligible for services is transferred out of the district to another school district after 7/1/22 but on or before 10/14/22.

**Description:** Student was a new referral (referred on or after 7/1/21) and eligible for services but transferred to another district between 7/1/21 and 10/15/21.

**DO NOT INCLUDE** in this submission file – student will be reported by the district he was transferred into, including the referral information, even though the original district conducted the evaluations, etc.

**Scenario:** A continuing special education student (found eligible 1 or more years ago) transferred out of the district to another school district on or before 10/15/21.

**Description:** Student was eligible for services but transferred to another district between 7/1/22 and 10/14/22.

**DO NOT INCLUDE** in this district's submission file – student will be reported by the district they were transferred to.

### Students Transferred into a district

**Scenario:** A continuing special ed. student (found eligible 1 or more years ago) transferred into the district from another school district after 10/15/21 but on or before 10/14/22.

**Description:** Student was eligible for services last year and reported by the other district in the 10/15/21 submission file but has since transferred to the district on or before 10/14/22.

The new district (the one the student transferred into) will report the student, including any reevaluation or annual review dates that occurred between 10/15/21 and 10/14/22, even if those meetings were held by the original district.

**Scenario:** A student, who was referred in another district on or after 7/1/21 and found eligible for services, is transferred into the district on or before 10/14/22.

**Description:** Student was eligible for services but transferred into this district between 7/1/22 and 10/14/22. The new district (the one the student transferred into) will report the student, including all the referral information and eligibility dates that occurred on or after 7/1/21, even if those meetings were held by the original district.

## Two Referral Chains

**Scenario:** Two referrals, both processes completed.

**Description:** Student was referred and found either eligible or ineligible on or after 7/1/21. Student is then either declassified (if found eligible) and then re-referred, or re-referred (if originally found ineligible). The student is then found eligible with this new referral.

Data reported would use the data from the second referral (use the most recent referral date, consent to evaluate, eligibility determination, etc.).

**Scenario:** Two referrals, one process completed the other in progress.

**Description:** Student was referred and found eligible on or after 7/1/21. Student received services and was declassified (e.g. 5/2/22). Student is then re-referred several months later (e.g. 9/1/22) and consent to evaluate is received two weeks later (e.g. 9/15/22). Eligibility meeting won't occur until after 10/14/22.

Data reported would use the most recent referral and consent dates.

**Scenario:** Two referrals, one process completed, the other in progress, student receiving services on 10/14/22 based on the first referral.

**Description:** Student was referred and found eligible for Speech/Language on or after 7/1/22. Student has an IEP in effect for Speech/Language on 10/14/22 and is receiving services. Student was referred for Special Ed/Related services on 9/1/22. Consent to Evaluate was received on 9/15/22. Eligibility Determination meeting will not be held until after 10/14/22.

Data reported would be only the current referral for Special Ed/Related services, **not** the Special Ed services from the Speech Evaluation.

## Concurrent Chains

**Scenario:** Two referral processes, both open and occurring within the same time frame.

**Description:** Student is referred for Speech/Language on or after 7/1/21 and also has a Consent to Evaluate. Eligibility Determination meeting will not occur until after 10/14/22. Student also has a referral for Special Education and Related Services on or after 7/1/21 and also has a Consent to Evaluate. Again, The Eligibility Determination will not occur until after 10/14/22.

Data reported would be only the current referral for Special Ed/Related services, **not** the Special Ed services from the Speech Evaluation.

## Declassified Students

**Scenario:** Continuing special education student is determined to be ineligible for Special Education services during the Reevaluation meeting on or before 6/30/22.

**Description:** Student was eligible for services after 10/14/22, but the parents refused consent during a Reevaluation meeting on 04/15/21.

Data reported would only be the Special Education Classification code of “99” in the August 3<sup>rd</sup>, 2022 **SID Snapshot** and the student would **not** be reported to the 10/14/22 Special Education Submission.

**Scenario:** Continuing special education student is determined to be ineligible for Special Education Services during the Reevaluation meeting after 6/30/22 but on or before 10/14/22.

**Description:** Student was eligible for services after 10/14/22, but during the Reevaluation meeting the CST determined that the student was no longer eligible for the services

Data reported would be the Special Education Classification code of “99” in the October 14, 2022 SID Snapshot and Special Education Submissions.
